


**CITY OF TUSKEGEE, ALABAMA**

**WHEREAS**, of all beautiful things in life, the most beautiful, is character, and he who possesses a beautiful character is worthy of notice. A beautiful life is the fruit of a beautiful character. He, of whom we speak, is Lawrence McRae; and with a lasting gratitude for his exemplary life, his tireless and unselfish labor among us; the good he did the inspiration we imbibed; we dedicate this hour; and

**WHEREAS**, as Mayor and on behalf of the City Council of the City of Tuskegee, we recognize a life well lived. Lawrence McRae was an advocate for others; and

**WHEREAS**, it is our sincere hope, that joyful memories, mercy, and grace will rule your thoughts and rest within your family in the weeks and months to come. We pray that comfort and peace will reign. And ask that all pause and remember Lawrence McRae and his many good deeds; and

**WHEREAS**, Lawrence created the McRae Prostate Cancer Awareness Foundation. In 2007 and 2010, McRae Prostate Cancer Awareness Foundation started doing Community Outreach (PSA) testing with East Alabama Medical Cancer Center. In 2007-McRae Prostate Cancer Awareness Foundation purchased a mobile unit to be used to promote prostate cancer awareness at health fair throughout Alabama's Black-Belt. The mobile unit is used to disseminate educational material and serve as the host site for medical staff providing the prostate specific antigen (PSA) blood test for prostate cancer. In 2004- McRae Prostate Cancer Awareness Foundation (MPCAF) launched: Waging War Against Prostate Cancer in Alabama. From 2000 to present, McRae Prostate Cancer Awareness Foundation has participated in 100 health fair and attended 25 health seminars throughout the Black-Belt, advocating for early screening for prostate cancer, recruited over 5,000 men for participation in prostate cancer program initiatives, and has created, hosted, and managed a web site about prostate cancer. **WHEREAS**, of all beautiful things in life, the most beautiful, is character, and he who possesses a beautiful character is worthy of notice. A beautiful life is the fruit of a beautiful character. He, of whom we speak is Farrell Duncombe; and

**WHEREAS**, with a lasting gratitude for his exemplary life, his tireless and unselfish labor among us; the good he did, the things he taught and the inspiration we imbibed; we dedicate this hour; and

**WHEREAS**, Farrell Duncombe was born in Selma, Alabama and later moved to Montgomery with his family early in his childhood. It was his parents' dedication to serving that inspired him to do the same; and

**WHEREAS**, Farrell Duncombe raised his children as a living example of his most beloved mantra: "Only what you do for Christ will last". He was a former Montgomery Public School teacher, band director and administrator in addition to leading multiple congregations throughout the city, Duncombe was, to many, a source of inspiration and guidance.
